

AMENDMENT OF RESTRICTIVE COVENANT FOR ZONING CASE: C14-86-300

The City of Austin, a home-rule city, municipal corporation and political

subdivision of the State of Texas, in Travis County, Texas.

CITY COUNCIL:

CONSIDERATION:

Ten and No/100 Dollars (\$10.00) and other good and valuable consideration paid

by the Owner to the City of Austin, the receipt and sufficiency of which is

acknowledged.

WHEREAS, Home Depot U.S.A., Inc., a Delaware corporation ("Home Depot"), Saint Edward's University, Inc. and Brothers of the Holy Cross of Texas, a Texas non-profit corporation, as owners of all that certain property described in Zoning File No. C14-86-300, consisting of approximately 183 acres of land (the "Property"), as more particularly described in the restrictive covenant recorded in the Real Property Records of Travis County, Texas, in Volume 10787, Page 344 (the "Restrictive Covenant") imposed certain restrictions and covenants on the Property by the Restrictive Covenant of record; and,

WHEREAS, the Restrictive Covenant provided that the covenant could be modified, amended, or terminated by joint action of both (a) a majority of the members of the City Council and (b) the Owners of the Property at the time of such modification, amendment or termination; and,

WHEREAS, HOME DEPOT is the current owner of the Property identified as Tract 1 in the Restrictive Covenant on the date of this Amendment and desires to amend the Restrictive Covenant; and,

WHEREAS, the City Council and the Owners agree the Restrictive Covenant should be amended as to Tract 1 only;

NOW, THEREFORE, for and in consideration of the premises and mutual promises, covenants, and agreements hereinafter set forth, the City of Austin and the Owners, agree as follows:

- 1. Section 3 is amended to permit Construction Sales and Services and Plant Nursery use on the property identified as Tract 1.
- 2. The conditions imposed by Section 10 do not apply to Tract 1.

3. Section 11 is amended as to Tract 1 as follows:

> If any person or entity shall attempt to amend this agreement and covenant, the Owners, at their own expense, agree to notify all the person or persons owning real property within the Sherwood Oaks Subdivision and the property owners along Woodward Street between South Congress and IH-35, and the designated representative of a neighborhood association registered with the City of Austin whose boundaries include the Property, at least 45 days before presentation of the proposed amendment to any city body, including the Planning Commission, by U.S. Mail as per current ownership list available from the Travis County Tax Appraisal District, not included in any required notice by the City of Austin.

Section 12 of the covenant is amended as to Tract 1 as follows: 4.

> If any person or entity shall violate or attempt to violate this agreement and covenant, it shall be lawful for the City of Austin, a municipal corporation, its successors and assigns, and the South River City Citizens (the "SRCC"), to prosecute proceedings at law or in equity, against such persons or entity violating or attempting to violate such agreement or covenant to prevent the person or entity from such actions, and to collect damages for such actions. If the City chooses not to prosecute, the SRCC would not be required to post a bond in a preliminary injunction if the SRCC proves a violation.

- 5. Except as expressly provided for in this Amendment, each and every one of the terms, conditions, and provisions of the Restrictive Covenant, as set forth in the Restrictive Covenant, shall continue in full force and effect on and after the effective date of this Amendment.
- 6. The City Manager, or his designee, shall execute, on behalf of the City, this Amendment of Restrictive Covenant for Zoning File No. C14-86-300, as authorized by the City Council of the City of Austin. This Amendment of Restrictive Covenant for Zoning File No. C14-86-300 shall be filed in the Real Property Records of Travis County, Texas.


