Background, Authority, Website & List Serve

SRCC is the South River City Citizens Neighborhood Association, formed in 1972 by Jean Mather and Harriet Buxkemper -- both of whom still live in the neighborhood -- primarily in anticipation of a city-wide comprehensive planning effort and as a way of being heard at City Hall.

2010 Officers & Committee Listings

SRCC is formalized by our bylaws, which you may access, along with lots of other information, via the following website: <http://www.srccaustin.org/>. The web site is owned and managed by Jane Kellogg, not the association. The related list serve is also owned by Jane, not SRCC. Both have served SRCC very well for years, with Jane at the helm.

Membership & Dues

SRCC is a 100% volunteer organization of the residents, by the residents and for the residents. Anyone who lives within the SRCC boundaries is eligible for membership. Participation and meeting attendance is open to everyone within the boundaries, member or not. However, voting on issues is limited to members. You may bring an issue of concern to one of our meetings, and SRCC may vote on it and even take some action in your support without your ever being a member, although your membership is appreciated.

Membership dues are quite reasonable and have traditionally been used to pay for such items as production of the newsletter that comes out 3-5 times a year and should be delivered to your door; to participate in certain issues like trenching to stop the spread of oak wilt; to help fund the annual Fourth of July parade and picnic; to pay for occasional legal assistance; and to help fund our annual potluck dinner meeting for the election of officers each March.

Reputation

SRCC has an excellent and long-standing reputation with the City of Austin, which means that members of various City Boards and Commissions as well as City staff and City Council members will often suggest or insist that we be contacted by any person or group wishing to do anything in the neighborhood that requires City approval or other action. Our opinions on any such actions usually carry weight, and we often prevail. Over time, neighborhood influence waxes and wanes depending upon the makeup of City Council, so we can never really relax our vigilance.

Boundaries

SRCC's boundaries are S. Congress on the west, the Lake on the north, Ben White on the south, and IH 35 to Oltorf to Parker on the east. By no means is SRCC limited just to Travis Heights, as some think.

Over the past decade, the City of Austin has conducted a Neighborhood Plan process City-wide that has proven very confusing to us. SRCC was City-designated as the Greater South River City Combined (GSRCC) Neighborhood Plan Area minus our area east of IH 35, which was City-assigned to the East Riverside/Oltorf Combined (EROCC) Neighborhood Plan Area. This is an unfortunate bureaucratic decision. For purposes of SRCC, we still include both of these areas, although occasionally there are issues that threaten our solidarity.

I tell you this only in an attempt to clarify the situation in advance of sure confusion when one tries to distinguish among all the named groups. The official City Neighborhood Plans have official Contact Teams whose members must act occasionally when the City or a private interest wants to amend the Plan. Many of GSRCC's and EROCC's Contact Team members are also active in SRCC, which helps us all stay on the same page. Fortunately, most day-to-day business involving the City and our neighborhood is conducted at the SRCC level, rather than that of GSRCC.

Meetings

SRCC holds a regular monthly meeting on the first Monday of every month except occasionally when a holiday (such as the 4th of July or New Year's Day) conflicts. Meetings start at 7:15pm and are held in the basement activity room of Grace United Methodist Church located at 205 E. Monroe at Nickerson one block east of S. Congress Avenue.

The Executive Committee (see more below) also holds a meeting every 3rd Monday in the conference room of the Church to discuss upcoming agenda items and to vote on time-critical issues when necessary. These meetings begin at 6pm in the Church's Conference Room. More and more, these meetings are conducted online rather than in person.

Agendas & Postings

The agendas are put together by the President with input from the Executive Committee, Committee Chairs, residents, and others in search of neighborhood approval of some action. Anyone may request a place on an agenda by contacting an officer or other member of the Executive Committee. Per our bylaws, agendas must be made available to the membership at least 72 hours before the meeting. I aim to post a draft agenda one week before the following Monday evening meeting. The Final Agenda is available then at the meeting itself. Posting is on the list serve. We try to remember to do a reminder post the day of the meeting.

Officers & Executive Committee

The Officers of SRCC include President, Vice-President, Treasurer and Secretary, elected annually at the potluck dinner meeting in March. The bylaws do not address the issue of vacancies during the year, so we assume elections any time of the year to fill vacant posts are permitted. It is not uncommon to have co-officers to share the duties.

SRCC is divided into geographical Areas 1-8. Areas 3 and 4 are further divided into 3A & B and 4A & B, for a total of 10 areas. Each of these Areas has at least one, if not two, Area Coordinators. These people are your local points of contact for any neighborhood concerns. They also are responsible for distributing the newsletters within their Areas. Anyone may contact an Area Coordinator or an officer with an issue that may need to be put on an agenda for discussion and/or action.

The Executive Committee includes the Officers and Area Coordinators. You can find a list of all of us at the www.srccaustin.org website. Click "officers" in the top "FIND IT" section, then "more information." We are also listed on the back of our newsletters, along with a map showing all 10 Areas. At the very least, newsletters will come out in plenty of time to announce the annual 4th of July parade and picnic, and the annual potluck dinner/elections in March. The newsletter is posted to the website and distributed to each household.

Norwood Posse Hires Abatement Contractor

Thanks to many donations to the Austin Parks Foundation, the Norwood Posse hired abatement contractors to remove hazardous materials from the roof of the Norwood House at the end of April. Community volunteers then installed thick vinyl tarps, donated by Clear Channel Communications, to protect the house from further water damage. Now our focus is on hiring contractors to deal with the lead paint on the eaves and underneath the porch roof. Once that is done, roof restoration can begin. That will require replacing many rafters and about half of the roof decking...and, as usual, it will require more money. Bids are now being solicited for the roof work. We have about half of the \$8,500 already raised for this phase and continue to apply for grants and plan fund-raising events. Look for those on the list serve.

We asked the City's Parks & Recreation Department (PARD) for help with funding by using funds leftover from the \$84 million, 2006, bond package. In response to our inquiry, PARD advised that those funds are being dedicated to repairing the Liz Carpenter fountain at Butler Park, though no details were provided. We believe that both PARD, and the city, as owners of this property, should participate in fixing what they allowed to break. Please help us encourage city staff to help by contacting council members, the mayor, city manager, PARD director, etc. With a few clicks (www.ci.austin.tx.us) you can keep the fire lit under the city council and staff who are responsible for protecting our property...keep in mind that the Norwood House is "our" property!

Lorrie DeHaas Honored as Partners in Education Coordinator of the Year!

Congratulations to Lorrie DeHaas for being recognized as an outstanding volunteer who is making a big impact at Travis Heights Elementary. Lorrie was honored for her tireless efforts to work with Partners in Education (PIE) to keep the Math Mentoring program afloat at Travis Heights Elementary School (THES). The focus was on 3rd and 4th graders, a critical point in the math learning curve for our students.

Lorrie mobilized a critical mass of volunteers by leveraging resources from THES, PIE, the neighborhood and our local colleges. This involved putting aside her personal schedule and attending the full gamut of meetings--PTA, Campus Advisory Councils, Coffee Chats, Kinder Roundup, etc.-- to market volunteer opportunities to existing and future student parents, faculty and administration. This resulted in about 30 volunteers and subs to mentor three 4th grade classes and two 3rd grade classes on a weekly basis. She then trained the volunteers using the PIE training materials, with particular stress on the Positive Behavior System currently in place at THES.

To maintain momentum, Lorrie created weekly email reminders to volunteers regarding schedule changes, weekly exercises, substitution opportunities, and met regularly with volunteers to discuss the effectiveness of math exercises and student attitudes and behavior. To close the loop, she met with teachers to share the feedback and seek continuous improvement. Lorrie's boundless enthusiasm maintained excellent morale across the group because every volunteer felt valued and appreciated.

The results were outstanding. In both 3rd and 4th grade, there were incredible improvements between mid-year assessments and 3rd-quarter testing, with some classes' passing scores jumping by more than 50%.

Most recently, Lorrie organized an end of year TAKS party for students to celebrate their success. In her own words, "I loved every second of my role as a volunteer coordinator at Travis Heights Elementary and was honored by making a connection with all the students and volunteers." "It's people like Lorrie that make the community and Travis Heights Elementary a better place," said Sherri Woolley Ancipink, THES PTA Vice-President. "Her energy, never-say-die attitude, and dynamic ability to connect with students and volunteers have made a tremendous impact this year."

SRCC Neighborhood Watch & Patrol Program Gains Momentum

In April, we launched our official Neighborhood Watch and Patrol Program with a big kick-off meeting at Grace Church. Over 40 residents attended to collaborate and learn about the program as well speak with Austin Police Department (APD) officers, APD detectives, and other neighborhood watch representatives. It was very successful and we are excited to build on this momentum.

Officer Atilano Guerra (one of the SRCC's District Representatives) and two APD detectives explained why neighborhood watches and citizen patrols are incredibly important to APD and help tremendously in their efforts to fight crime. As we've been told before, APD's staffing does not allow for proactive patrols through neighborhoods in Austin - they are, unfortunately, perpetually in call-and-response mode. Because of this, they rely on citizens to call 911 when they observe any criminal activity or any suspicious activity. Organized Neighborhood Watch and Patrol programs greatly enhance a neighborhood's ability to do this reporting in an effective way. By getting to know your neighbors and their patterns, you are better able to identify situations where something seems suspicious and call it in to 911.

John Luther, Chair of the Barton Hills Neighborhood Watch and Patrol program, spoke about Barton Hills very successful neighborhood watch training and citizen patrols. He has built an elite team of volunteers that train their residents on everything from identifying people and cars to 911 operators to making their homes safer and less prone to break-ins. He has also put in place a patrol program that allows residents (after training) to patrol their entire neighborhood identifying suspicious activity and calling it in to 911. These residents receive a magnetic "Neighborhood Watch" sign for their cars in order to make it clear to would-be criminals that the neighborhood is watching at all times. These two programs have dramatically reduced the number of auto and home burglaries in the Barton Hills neighborhood. John has graciously offered to help us implement a similar program in the SRCC neighborhoods, and we will be taking him up on his offer.

Finally, we reviewed a draft of our "How to Start a SRCC Neighborhood Watch" document that outlines the steps for becoming a Block Captain and becoming a part of the SRCC Neighborhood Watch and Patrol program. As we mentioned in the last newsletter, our approach is to blanket the SRCC neighborhoods with a network of "watch areas" that are each owned by an individual Block Captain, who will take ownership of getting the residents in that area involved. We managed to get 16 Block Captains to volunteer and, since the meeting, they have been defining their watch areas and organizing their neighbors. If you would like to get involved in the program:

3. Watch the main SRCC Yahoo! Group for announcements about general meetings and training sessions every couple of months. These meetings will be geared for bringing new members into the program as well as training existing members on neighborhood watch and patrol tactics! ❧

Blunn Creek Watershed Improvements Continue


There has been a flurry of activity along the banks of Blunn Creek in recent months aimed at improving water quality, erosion and flood control, and wildlife habitat:

- **Blunn Creek Nature Preserve** - Three neighborhood volunteer events were held this spring at the Preserve to improve biodiversity and wildlife habitat. Volunteers pulled ligustrum, planted natives, spread mulch, repaired trails, and picked-up trash. Over 40 volunteers turned out at each event. In addition to the volunteer events, the City and Austin Parks Foundation made substantial progress removing mature ligustrums at the south end of the Preserve (that were later spread on the trails as mulch). - **Warehouse Row Water Quality Ponds** - Two new regional water quality ponds being constructed by the City at the end of Warehouse Row (just north of Ben White) are almost complete. The ponds will capture and filter rainwater runoff from an approximately 90-acre industrial area at the headwaters of Blunn Creek.

- **AISD Cold Storage Facility Expansion** - AISD is expanding its cold storage facility located at the east end of Alpine at the headwaters of Blunn Creek. As part of the construction project, the existing water quality and detention ponds are being expanded to comply with current City standards.

- **Stacy Park Rain Gardens** - On May 6th the City formally dedicated the two new rain gardens that were recently completed in Stacy Park near Woodward/Annie and Eastside. Check them out if you haven't seen them yet. The gardens are planted with natives that absorb and filter rainwater runoff from the nearby streets. The City has announced plans for another rain garden in the same area. Consider putting one in your yard if you are interested in conserving water and reducing urban impacts to your local creek.

- **Sherwood Oaks Storm Drain Project** - Construction continues on the year-long project that aims to alleviate flooding problems in Sherwood Oaks. New storm drain pipes have been buried under many of the streets. The article below provides more details on the Sherwood Oaks Storm Drain construction.

Sherwood Oaks Storm Drain Project

Five months down and seven more to go before homeowners in Sherwood Oaks can breathe a sigh of relief the next time a big rain heads for our neighborhood. As of late May, this is the current status of the project as reported by Stephanie Lott of Watershed Protection:

Blunn Creek Preserve: The work in the Preserve is not complete. The bulk of the storm drain line between East Side Drive and the Preserve has been placed. Remaining work includes constructing the outfall in the creek, placing the riprap on each bank at the outfall and cleaning up and restoring the Preserve. Rip rap is large stones that slow down the water and help prevent erosion.

Blunn Creek Tributary (between Sherwood Lane and Friar Tuck Lane): Construction of the retaining wall has slowed because we have found a significant amount of water at the bottom of the channel. We understand that this channel probably looks bad to the people whose yards overlook it, but we've taken steps to shore it up and will put additional measures in place to further reinforce it. The purpose of the retaining wall is to prevent erosion of the properties immediately adjacent to the outlet (where water enters the open channel from the storm drain culverts.) The retaining wall will slow down the flow of water and prevent any further erosion of the yards and will extend about 150 feet into the tributary. It will be about 10 feet from the top of the wall, or the general level of the yards, to the bottom of the wall. The final width of the channel through the retaining wall will be about 15 feet. The crux of this is that we know the excavation looks awful right now, and we can understand why the adjacent property owners may have concerns. Rest assured that we have taken measures, and will take additional measures, to ensure the protection of property. The scale of the excavation is deceiving, since the end result will be something of much smaller scale. The remainder of the channel work includes clearing brush, widening the channel and placing riprap to prevent further erosion of the creek.

Carnarvon Lane: The large street cut for installation of the storm drain is complete.

Friar Tuck Lane: Work on the storm drain installation has already began mid-May. The contractor will trim trees as the work progresses. This is minor trimming, previously coordinated with the City of Austin Environmental Inspector. All trees will be trimmed within the right-of-way and consists of removing low hanging limbs to increase the clearance between the roadway and the trees. The wastewater line in Friar Tuck has been completed for several weeks.

Little John Lane: Work within the easement between 2411 and 2413 should wrap up before Memorial Day. Please avoid parking along the curb between these two houses.

Long Bow Lane: The waterline in Long Bow is installed and has been tested. The only portion of storm drain that we need to install runs between the Blunn Creek Tributary and Friar Tuck.

Oltorf Street: We now plan on beginning the bore for the waterline relocation at Blunn Creek sometime in June. We will set up a long-term lane closure on Oltorf taking traffic down to one lane in each direction for the duration of the work. This work includes a large, waterline relocation and installation of large box culverts for the storm drain.

St. Edwards Drive: The large street cut for installation of the storm drain is complete.

Sherwood Lane: The large street cut for installation of the storm drain is complete.

Every street in Sherwood Oaks: Even though the large street cuts are completed in many areas, work on every street impacted by the project remains: 1) inlets that allow water to enter the new underground system; 2) joints (large concrete boxes) that connect the various underground lines; and, 3) some minor work within each manhole to finish out the project. Finally, various streets within the neighborhood will receive fresh pavement. The idea is that we leave the streets in Sherwood Oaks better than we found them. ❧

East Riverside Corridor Master Plan

The Regulating Plan & Zoning Changes Kickoff Meeting held 5/17/10 was poorly attended, with most attendees new to the City's planning process. An overview of the Master Plan process, vision and timeline were presented. In explaining how the regulating plan will be developed, City staff repeatedly used the words "hard choices" and "sacrifices." EROC residents know only too well what that means - current residents lose.

Oddly, the relationship between density and rail ridership is still up in the air. In February when the Master Plan was adopted, Staff was directed to determine the density needed to support rail on Riverside. (Apparently, neither CapMetro's figures, nor the Brookings Institute studies, nor a plethora of other available studies are of any use.) While I understand the importance, and fully support, tailoring the information specifically to this Corridor, the City should stop relying on developers to provide such critical information. Talk about the fox guarding the henhouse. This information is needed prior to making recommendations on the density bonus-trade-offs and removal of single-family compatibility standards.

The focus of the initial meeting was how to improve the community input and engagement process and the establishment of a "small representative working group." City staff's proposal of a working group comprised of eight members, of which only two would be neighborhood representatives (one from EROC and one from Montopolis) was not well received. Those who had never participated in previous City planning efforts were especially vocal in their opposition to such an arrangement.

I'm sure that a number of suggestions made by participants will be incorporated into this planning phase. My impression, however, is that this is merely a repeat of the EROC Neighborhood planning process - Staff will solicit input from resident participants, listen carefully, and ignore it. Zoning Committee Update: 1307 Newning Rezoning and 1608 Travis Heights Boulevard Demolition Permit

Request for Rezoning and Neighborhood Plan Amendment for 1307 Newning Ave.

In March 2010, SRCC was notified of an application to rezone 1307 Newning from its current SF-3 "Family Residential" (which is what most of the surrounding residential properties are zoned) to SF-5 "Urban Family Residential"

to allow townhomes. The related Neighborhood Plan Amendment (NPA) case was to change the FLUM (Future Land Use Map) from "Single Family" to "Higher Density Single Family".

The speculatively built monster structure at 1307 Newning is a roughly 8,000 sq. ft. duplex with two 4,000 sq. ft. units. Normally, the duplex would be governed by a condo agreement and the units sold separately. The applicant, Ms. Brenda Reese, came before the SRCC membership on May 5th and before the NP Contact Team the following evening. Ms. Reese's sole reason for her land use change requests is to help potential buyers obtain financing (and to help her get the units sold). According to Ms. Reese, since the financial bust and new federal regulations have been put in place, it is very difficult to get financing for condo regimes of less than 10 units, while townhomes are more easily financed. At least in part, she is following the recommendations of City staff, which is very irritating, especially after both SRCC and the NP Contact Team voted unanimously against Ms. Reese's requests. Staff supported her requests in their reports to the Planning Commission when it heard the case on May 11.

Numerous SRCC neighbors spoke against the cases, the two primary arguments being that:

- (1) it is not the City's responsibility to bail out a bad investment, especially on the backs of local residents, and
- (2) SRCC has worked diligently for over 20 years to first roll back residential zoning to SF-3 and then to keep it there.

In a surprising vote, the Planning Commission agreed with us in a unanimous vote against the applicant. The cases go to City Council on June 10th.

Demolition Permit Request for 1608 Travis Heights Boulevard

On May 24th, the Historic Landmark Commission heard a request for a demolition permit for this house, which was reduced down to a shell of its exterior walls by a previous owner. That owner blatantly destroyed most of the cottage over a three-day weekend more than a year ago with only a "remodel" permit in hand! The neighbors asked for historic zoning for which only the exterior has to be maintained by the new owner. The Historic Landmark Commission was not impressed with the new owner/developer's plan for a 3,000 sq. ft. home; all asked if he could incorporate the remaining façade into his design. The matter has been postponed until June 28th; the developer will present his case to the Subcommittee on Appropriateness on June 14th. ❧

Twin Oaks Branch Library Replacement Project: Although the contractor still has site work corrections to make along with interior and exterior punch list tasks to complete at the new Twin Oaks Branch Library location, the Library Department has established a schedule for closing the lease space Twin Oaks Branch Library at 2301 S. Congress and then reopening the library to the public in its permanent home at 1800 South Fifth Street:

As of May 31, 2010, the Twin Oaks lease space branch library will close to the public and reopen at its new, permanent location on Saturday, August 21, 2010, at 10:00 AM. On Tuesday, June 1, 2010, the Twin Oaks lease space library will be closed and boxing of the collection for relocation will begin.
