Sherwood Oaks residents Robert Kazenel, David Swann, and Elloa Mathews, as well as our SRCC President Sarah Campbell, met with St. Edwards University officials in January to discuss campus noise issues.

For several years, neighbors have expressed their dismay at the level of amplified music at campus events that has prevented residents from enjoying their homes. The meeting was the result of neighbors tiring of addressing the noise on an ad hoc basis and sought assistance from Cristina Bordin in the SEU President's office as well as the Director of Athletics, Debbie Taylor. Ms. Bordin agreed to work with neighbors to resolve the issue and has reported that SEU does have a noise policy.

Imagine Austin

AS MANY OF YOU KNOW, THE COUNCIL HAS HIRED a consulting firm to develop a new masterplan for the City called "Imagine Austin." Despite valiant attempts by the consultant and city staff the majority of citizens are unaware of the work in process. After urging by neighborhood representatives, the Council has finally started televising the thirty member task force's meetings on Channel 6 and during the last two meetings members have had microphones and their comments were recorded.

A major element of the plan is the transportation layout. What is missing is the required increased density. The transit corridors, including light rail, would require a 7,500 population increase for every two miles. Although the map shows a slender blue line for the rail adjacent to the existing residential, the intention is to replace blocks of single family with commercial and multi-family about one half mile wide along the corridors to provide the necessary ridership.

Riverside (from 183 to the Long Center) and South Congress (from Downtown south to IH-35 at Route 45) and parts of Lamar are designated for light rail.

South Congress from Academy to Live Oak currently has only a half of block width of commercial zoning in both SRCC and Bouldin. Current compatibility rules limit height to mostly 30 feet.

If Council approves this plan, they would have to approve amendments to the affected existing neighborhood plans to implement these proposals. If the recent ruling on the Park PUD is any indication, six out of seven Council Members would feel free to do so. Our neighborhood will be heavily impacted. I will bring the latest map to our next meeting. **We will have to respond individually and as an organization to this proposal.** ☼

Norwood Update

JANUARY 2011 MARKS A NEW CHAPTER for the Norwood House. Casabella Architects, local consultants hired by PARD, are now studying the entire property with the goal of proposing three future uses of the property in June. Jaime Beaman, the president of Casabella Architects, met with me to "download" all relevant information assembled by the Posse. Since the Norwood property is, in fact, a city park, its future will be tied to a larger vision of what is best for our neighborhood as well as the city. Beaman appreciates the great potential of the property and appears intent on crafting proposals that honor the history of the site, while transforming it into an asset to our park system.

As to the future of the house itself, the historic zoning does not guarantee its survival. Well aware of long-term SRCC interest in the Norwood House and wishing to complete a thorough, comprehensive study, Casabella plans on at least three community meetings to solicit input. Once community input meetings have been scheduled, details will be posted on the SRCC list serve.

Casabella will eventually present their recommendations regarding restoration, demolition, or repurposing. The Norwood Posse remains committed to either restoration or duplication of the house, and is well aware that the cost of each option will be a deciding factor. We believe there is well documented demand for facilities such as the Zilker Clubhouse, and that the Norwood House could help meet that demand, while generating enough revenue to make it financially self-sufficient. ☼

SRCC Neighborhood Watch Update

THE INCREASE IN CRIME THAT WE ALL WERE beginning to notice back in October continued to escalate through the holidays. From home burglaries, to auto burglaries, to even auto thefts, the end of 2010 was a discouraging return to familiar crime levels after a relatively mild summer. Many residents have even wondered whether the neighborhood watch efforts could actually have an effect.

Fortunately, we are blessed with some encouraging news from nearby neighborhoods that have truly embraced their neighborhood watch programs to make an enormous impact on their streets. For example, with the help of some dedicated APD officers, John Luther, chair of the Barton Hills Neighborhood Watch and Patrol, has built a truly impressive citizen-led watch and patrol program. Using a combination of targeted home crime protection efforts (deadbolts, lighting, etc.), traditional neighborhood watch tactics, and citizen crime patrols, BHNA has **decreased** the incidents of vehicle **burglaries by 72%** and residence burglaries **by 53%** in the 2010 holiday months (versus 2009).

On January 31st, SRCC invited John Luther, along with Officer Dwayne Kinley and Commander Ernie Pedraza, to tell us more about their program, what elements of their program have lead to success, and how we attack the burglary problem we are seeing in the SRCC neighborhoods. The meeting was eye-opening and the small group of SRCC block captains and concerned residents left with a new perspective on how we can reinvigorate our own program to have a similar impact on our continuing crime problem. In the coming weeks, the SRCC Neighborhood Watch Program will roll out new efforts to supplement our existing network of block-captain-led watch areas with a centralized approach focusing on the following three areas:

ASSISTANCE - Reach out to neighbors who have been hit by criminal activity and support their efforts to protect themselves against future incidents. Assist with physical methods of crime prevention, such as securing deadbolts or improving lighting, as well as behavioral changes such as parking habits or hiding valuables.

AWARENESS - Communicate to neighbors when crime has occurred in their area. Send out regular crime database notices on the list-serve as well as targeted fliers on cars and doorsteps in the immediate area of the incident. Increase the awareness of these crimes in the parts of our neighborhood that are hit regularly.

DETERENCE - Continue to educate block captains and watch areas about calling 911 whenever some-

thing suspicious is observed. Use the existing SRCC areas to divide up the neighborhood into more manageable sections and recruit volunteers for citizen foot and car patrols in each one. Erect neighborhood watch signs in visible areas throughout the neighborhood. Show criminals that they are being watched and that we are no longer easy targets.

This approach will require strong, centralized volunteerism and we strongly encourage anyone who is interested in contributing to contact Marc Davis, Chair of Transportation and Public Safety Committee. ☘

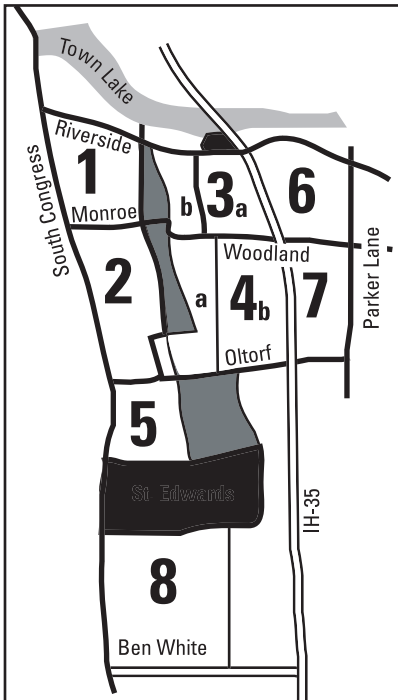
