Resurrecting Norwood House

In 1922 Ollie Norwood built his home overlooking what is now Lady Bird Lake. He added a fine teahouse/gazebo, a state of the art greenhouse, terraced gardens and one of Austin's first geo-thermal-fed swimming pools. The classic bungalow style house quickly became one of Austin's showplace homes. Ollie went on to build the Norwood Tower (1927) in downtown Austin, said to be the world's first fully air conditioned skyscraper (15 floors!) He thereby gave the city's expansion its first big business boost.

His wife, Calie had a great grandfather, Edward Osborn LeGrand, who was the 58th signer of the Texas Declaration of Independence, and one of Sam Houston's colonels at the battle of San Jacinto.

The house was sold in 1963 to Joe Small, who moved his western history magazine publishing company to the site. In the early 80's his family decided to sell the estate to investors who saw great potential in this very scenic site.

SRCC steadfastly fought these interests, successfully staving off unwelcome development. In 1985 the last owner put the property on the market. Austin's Park and Recreation Department staff saw the site's great potential and the city council authorized \$2.5 million in certificates of obligation to buy it. What was missing was a fundable plan to transform the house into a usable public facility. So it has just sat there, abandoned.

In 1988 the Women's Chamber of Commerce launched a restoration effort in conjunction with PARD and the City Council to renovate the house and transform it into a visitor's center and an institute for the economic impact of women's issues. They

organized a gala fundraiser in 1992 with wide support from the business community. But dreams of turning this project into a showcase of the importance of historical preservation diminished. After moving the house back to its original site, the Chamber let the unfinished project go in 1999, and it was once again abandoned. Since then vagrants have been in and out, oblivious to the risks from asbestos exposure. Today there are holes in the roof, the ceilings are falling in, the windows are boarded up....and the City dutifully mows the lawn around the fence that surrounds it.

WHERE WE STAND TODAY

SRCC members have responded to this regrettable situation by convening the Norwood Committee., a.k.a. the Norwood Posse. These volunteers are picking up where the Chamber left off. Our first action has been to cover the house with tarps to minimize water leakage onto the fine wood floors. A neighborhood contractor has examined the house and says it is fixable. Previous estimates to PARD have been around \$1 million. The Norwood Posse firmly believes that with creative thing it can be done more affordably. PARD says they would do it, but their wish list is long, and funds are short.

We're off to a good start on the outside the box thinking. The architect who worked on the Chamber effort has agreed to help us and has many files about the last renovation plan. Both Travis County Adult Probation and Austin Community Court have agreed to refer clients who are required to perform community service restitution, possibly carpenters, plumbers, etc. Numerous other contacts are being made to assemble a coalition of interested parties that, together, can bring new life to this neglected historic structure.

The evolving restoration plan places heavy emphasis on volunteer labor, donations of needed materials by local businesses, grants, and, most importantly, tax -deductible donations by those who share the vision of restoring this south Austin landmark. We will announce a non-profit foundation that will be selected to accept your donations soon. Your checks and time or resources will help save a historic treasure and invest in a public park facility. This is a great opportunity to visibly change a part of our neighborhood and contribute to the public good.

Historic District Update

Fighting teardowns one-by-one can't save the rich history of our community. Until we create a local historic district, it's tough to preserve individual structures, unless they attain individual Historic Landmark status. The neighbors of three 1920's workingman's bungalows on Monroe Street fought valiantly but could only save the corner house, 500 Monroe, by claiming Landmark Status because its builder, Fred Malone had lived there. Malone was a beloved Travis County Clerk who had developed the entire block as well as two others in Travis Heights. On the edge of the neighborhood, the sadly re-modeled funeral home at 1811 S. Congress, also known as The Birkner House, didn't stand a

chance for adaptive re-use without a truly visionary design team at the helm; it will be demolished and replaced with a three-story Vertical Mixed Use structure.

Preliminary survey results report that 74% of structures qualify. The more detailed research required for the application for both a Local Historic District and a National Register Historic District will begin this month. Volunteers will meet at the Austin History Center for training starting in June. If you would like to help with the upcoming full survey and research, contact me Melanie@HistoricTravisHeights.org.

The Council Listens

There is proof that a flood of e-mails, phone calls and letters do influence Council actions.

The first big effort was "Save Town Lake," but more recently we've had two successes with Council initiated ordinances. Council Member Martinez proposed to increase the areas where billboards could be erected on certain scenic

roadways. After the public's response, he withdrew that part of the ordinance and is now proposing to reconsider an earlier ordinance that reincarnated non-profitable signs to a better location at a slightly reduced size.

The second recent event was Council Member McCracken's proposed ordinance amendment to remove the protection of the compatibility provision for single family residences in the VMU. After our wonderful Danette Chimenti and others met with him, he withdrew that amendment. I'm sure that our e-mails helped also.

East SRCC Report: Light Rail Proposal

Senator Kirk Watson noted in the American-Statesman article of 5/18/08 "How the Possible Light Rail Election Flamed Out," that key questions had to be answered before the City's light rail proposal is ready to go before the voters. The proposal was presented by Councilmember McCracken, Mayor Wynn and the ROMA Group at the 4/22/08 Mobility Workshop. Many of Sen. Watson's concerns mirrored SRCC's: lack of information on cost, financing, and operation; incomplete details on routes and selection method; no determination of the type(s) of rail proposed, and for certain segments, not even a firm commitment to rail; and no information on neighborhood impacts. We are fortunate that Sen. Watson insisted that specifics be provided and the proposal be thoroughly scrutinized using the "decision tree" approved by CAMPO's working group on 5/5/08. The proposed plan won't go before voters until it has been investigated and, hopefully, revised to provide definitive answers to the myriad questions raised by the initial, woefully inadequate, proposal. Heartfelt thanks to SRCC member René Barrera for his commitment, as Chair of CapMetro's Customer Satisfaction Advisory Committee ("CSAC"), to involve CapMetro in this process.

A Planning Commission subcommittee has had at least two hearings on the plan with staff updates. It went to the full Commission on May 27 and will be on the agenda for the City Council on June 18. The Plan as presented (beautifully) by staff is over a hundred pages long. How it will be presented and how much time will be allotted for community input may be a problem.

The environmental section has mostly minor proposed changes, but after that the suggested changes increase significantly. Greg Kiloh, in the Development section, admits that he doesn't agree with the sustainable development philosophy of the Plan. Make Your Yard Habitat Friendly!

The City of Austin and National Wildlife Federation are challenging Austin neighborhoods to certify the most number of yards within their boundaries as wildlife habitats. Participating neighborhoods will have the chance to help Austin earn points towards becoming certified as Texas' first NWF certified Community Wildlife Habitat.

The **Neighborhood Habitat Challenge begins May 1 and ends Oct. 31**. The top three neighborhoods that meet the challenge criteria and certify the most number of habitats will be awarded First, Second and Third place prizes. Neighborhoods must also organize a community invasive plant removal and promote gardening for wildlife through their newsletters and websites in addition to certifying the highest number of yards as habitats during the contest period. Residents can certify their yards by visiting the National Wildlife Federation's website, www.nwf.org/gardenforwildlife or by requesting a pre-paid habitat certification application (limited quantity) from the Wildlife Austin program at 327-8181 x29.
