It's Not Just About Fixing Up an Old House!

very preservation expert agrees that protecting a historic structure from further deterioration is step one. Since the roof of the Norwood House leaks, this is our first step. If you or I owned the Norwood House, we could remove the existing shingles & felt, temporarily patch the holes, and install a protective shield, with the help of our friends in 2-3 days, at almost no cost. The debris would need to be hauled to a special landfill, since the felt contains asbestos. Although it was deregulated ten years ago, roofing felt on public buildings requires a much more costly remedy (even though the users are private citizens). For starters you need: a licensed abatement contractor (\$3,000 to \$8,000), an air monitor during removal (\$650 a day), and a special landfill. And that's just the beginning. Lead paint was used throughout, and asbestos is in the interior wall plaster. That part can only be done by the experts and that's fine as we don't need to do that now!

As you can tell, these costs add up, but our immediate goal is protection. The Norwood House restoration fund at the Austin Parks Foundation has a current balance of \$6,500. Hopefully we won't need much more for this first critical step.

So how much is the city chipping in to fix what they broke? For the last 18 months the city has said that there is no money available. During that same 18 months, \$1.4 million was paid to a firm to design the controversial boardwalk. By the time you read this we might know whether the city council has added another \$590,000 to complete the boardwalk design. So public funds can be found; clearly what's lacking is the political interest and will.

Once the Norwood House is restored and becomes a valuable part of our park facilities, the conditions that allowed the house to fall so badly into disrepair will remain. PARD has never been adequately funded, so proper maintenance of existing



Victory for the Neighborhood!

arly this year, the Congress Avenue Baptist Church (CABC), filed applications with the City to (1) rezone its property at 1511 S. Congress and to (2) amend our Greater South River City Combined (GSRCC) Neighborhood Plan Future Land Use Map (FLUM) -- yes, a mouthful! This required review and commentary not only by SRCC, but also by the GSRCC Planning Contact Team members within the neighborhood, a creation of City Planning.

The CABC property was zoned SF-3 (single family), like most of the neighborhood, but unlike most of properties facing S. Congress. Also unlike most properties along S. Congress, which are only one-half block deep before an alley divides them from residential properties, CABC is a full block deep. The rezoning request was to intensify the entire tract. The amendment request was to change the FLUM from Civic to Commercial. Both SRCC and GSRCC agreed to Commercial zoning and use on the western (S. Congress) half of the tract, but differed on the east half of the block surrounded on three sides by SF-3 residential uses. In an intelligent attempt at compromise, GSRCC voted in May to recommend Neighborhood Office zoning for the eastern half. In a more emotional and impassioned vote in June, SRCC recommended the eastern half remain SF-3.

Mary Lovell began gathering the required 20% of nearby resident signatures to validate a petition AGAINST the Church's request on the eastern half and FOR keeping it SF-3 zoning. Greg Jacobson, a new nearby neighbor, and Mary met with City Zoning staff and with City Council Members to argue for SRCC's position. While the Planning Commission voted on August 25th in favor of CABC's requests, the City Council voted in favor of SRCC's position several weeks later and to not challenge the valid petition. The Church could not budge any of the petition signers to change positions, so in the end, CABC agreed to leave the eastern half of its tract zoned SF-3 with a Civic use.

This is an especially sweet victory because SRCC took a bold position against all odds, AND because other Councils have overridden valid petitions collected by citizens, a legal path of objection. Thank you, Mary and Greg, and all others who wrote and/or visited staff, Planning Commission and City Council Members and attended public meetings. And many thanks to Council Members Laura Morrison, Bill Spelman, Chris Riley, and Randi Shade, who agreed in advance to support the valid petition prompting the Church to withdraw its request for commercial zoning on the Nickerson side of the property.

Proposed Elimination of Bus Route 9 by Capital Metro

n a recent SRCC newsletter I wrote an article announcing the installation of a handsome new bus stop in our neighborhood. I encouraged residents to consider taking the bus as an alternative to driving. So I'm disappointed to write that Capital Metro is proposing to eliminate our Route 9. The decision is based on several factors which you can study in documents posted on their website (see links below). Service Plan 2020 is a comprehensive analysis of the bus system and provides a plan for growth over the next 10 years.

This article is intended to raise awareness, rather than summarizing all the issues and perspectives. Bus Route 9, Enfield/Travis Heights, is a north-south route reaching from Walmart on Ben White to 35th St (near Laguna Gloria). Capital Metro's ridership studies conclude that the number of riders using the portion of the route that runs through the Travis Heights neighborhood is not high enough to be cost-effective. Riders who use bus stops along Oltorf, East Side, Live Oak, Travis Heights and Monroe will have to go to Congress Avenue to board a bus.

On Friday October 16th, Capital Metro Senior Planners, Roberto Gonzales and James Gamez, met with neighbors to discuss the proposal to eliminate Route 9. We expressed our concerns about losing the service and discussed route alternatives. They described the method of ridership statistics and said they are continuing to monitor ridership for Route 9 due to the neighbors' concerns. We learned that Route 29 which serves the Zilker and Barton Hills neighborhoods is also proposed for elimination. Representatives of SRCC agreed to contact both neighborhood associations and explore opportunities to coordinate our efforts to retain core service to our areas.

If you rely on Route 9 to get to work and other destinations, or if you believe that convenient public transportation reduces car congestion in the downtown area, **now is the time to let Capital Metro know**. Sherwood Oaks/Area 5 Update

National Night Out

About 20 neighbors braved the heat and mosquitos to eat pizza and meet with the Sherwood Oaks District Representative from APD, Officer Ray Lopez as well as South Central Area Commander Lt. John Hutto. Kids and dogs played at the entrance to the Blunn Creek Preserve while adults discussed crime issues in the neighborhood.

Vote on Variances similar to Board of Adjustment stance

Due to the number of carports and other structures being illegally built in the city setbacks in Sherwood Oaks, neighbors voted unanimously less one abstention at the October meeting to send a letter to the city stating that SRCC does not support granting variances regarding carport setbacks. The most recent variance request for a carport built in the setback required five hearings at the Board of Adjustment, which first denied the request unanimously in June, before the applicant then tried to make a hardship case based on fairly insignificant trees. The Land Development Code requires that hardships may only be granted based on a physical impediment on the property such as a protected tree (19" diameter or greater), topography or lot shape.

Nine out of ten cases at the Board requesting a variance have already built the structure in the easement without getting a permit and nine out of ten have no hardship. Board members at the Oct. 12 hearing expressed their continued disappointment in the number of these cases while discussing how much time these cases consume on the Board's agenda.


